## 2019 – 2020 and 2020 – 2021 Annual General Meetings

### Election of Office Bearers and Increase in Annual Subscriptions

The long postponed 2019 – 2020 and 2020 – 2021 Annual General Meetings of the Guild were held on Monday the 29<sup>th</sup> of November.

Following the presentation of reports from the President and Treasurer, the statements of accounts for the 2019 – 2020 and 2020 – 2021 Financial years were received and approved by the members attending.

The committee for the coming year 2021 – 2022 was elected and this is **President**, Eric Estlin, **Vice President**, Adrian Roads, **Secretary**, Dr Malcolm McKay, **Treasurer**, Kevin Saunders; **Editor**, Fred Bienvenu, **Committee Members**; Chris Cosopodiotis, Barry Thomas, John Accardo, David Henderson and David Pearce.

As announced in the previous issue of *Very Light* the matter of the Guild's finances were discussed.

The President Eric Estlin told the meeting that the Guild's financial position has been deteriorating over the passing years. We have experienced falling income and rising costs and our financial reports each year have made depressing reading. Should we proceed diminishing our wealth annually we will probably have a life of 12 more years before the Guild will become financially unviable with the complete dilution of the hard earned fighting fund. He mentioned that part of this was due to the necessary cost of creating a first rate website and producing two excellent journals twice a year, plus other costs continue to rise whilst our income stagnates. Membership numbers mark time with new member numbers almost offset by natural attrition.

Furthermore the concept of Paid Life Membership was conceived many years ago, when annual subscriptions were much lower. However members benefits have improved with costs increasing considerably. The President announced that the option of Paid Life Memberships will be reconsidered by the Committee, with the object of not offering it going forward.

After calculating the financial position the President told the meeting that the Committee has arrived at the suggested following increases.

Full and Family Membership to rise from \$75.00 PA to \$105.00

Pensioner Membership Fee to rise from \$55.00 PA to \$75.00 PA

Country Membership to rise from \$45.00 PA to \$75.00 PA

And that a one off levy be placed on Paid Life Members of \$30.00.

The new fees would come into effect from the renewal of memberships for the 2022 – 2023 financial year.

The motion was put and general discussion invited, with the request that any suggested changes to the quantum of subscriptions be supported by costings of those suggestions.

Discussion of the proposed motion touched upon seeking further means to address static membership by boosting advertising in online sites and in printed magazines and journals. This was referred back to the committee for discussion of the wording and costs.

Following the discussion the following motion was put -

*“It is moved that the annual membership fees of the Antique & Historical Arms Collectors Guild of Victoria, Inc. be increased as follows –*

*Full and Family Membership is to rise from \$75.00 PA to \$105.00*

*Pensioner Membership Fee is to rise from \$55.00 PA to \$75.00 PA*

*Country Membership is to rise from \$45.00 PA to \$75.00 PA*

*There will be a one off levy on Paid Life Members of \$30.00.*

*The new membership fees will come into effect from the renewal of memberships for the 2022 – 2023 financial year”.*

The motion was carried.

### **Monday Meetings 2022**

The dates for the Guild Monday Meetings are **January 31, February 28, March 28, April 25, May 30, June 27, July 25, August 29 (AGM), September 26, October 31 and November 28.**

The committee has decided to make all meetings a Buy and Sell night. We want members to bring along items for sale which can include exempt firearms i.e. pre-1900 genuine antiques like single shot percussion pistols, flintlocks etc. and other types of exempt firearms such as longarms taking obsolete ammunition.

At this time we anticipate that there will still be some COVID requirements in place in the early part of 2022. Accordingly we will quote the current conditions, with the proviso that these will probably be modified in coming months.

Members attending will be required to record their attendance in one of two ways -

1. The Guild has a QR Code which is displayed and members may record their presence by using their smartphones as they would if attending restaurants or other venues where the use of the QR Code is a condition of admission, or
2. Any members who do not have the smartphone facility to use a QR Code to record their attendance will have to do so by writing their name and contact details (name, email address or phone number) on the record sheets which will be placed on the table inside the doors to the Hall itself.
3. When in the Hall the social distancing rule is still to be observed and face masks must be worn.
4. All attendees must be double vaccinated. Proof of vaccination must be provided if asked.

## **Some Firearms Regulations Updates**

### **Gel Blasters**

Over the past 12 months or so the Secretary has received queries from members regarding Gel Blasters. The police consider that if these have the appearance of an operable firearm, purchase and possession is governed under the provisions of the *Control of Weapons Act*. The Guild is an approved organisation under that *Act* so if anyone is considering purchase of a Gel Blaster then a current Guild membership card is sufficient to meet the requirements.

### **Storage Requirements for A/B Licence Holders**

Earlier this year changes were announced to the storage requirements for firearms held under A/B licences in which the wall thickness of the safe or container was increased to 1.6mm steel. L&RD have announced that the legislative amendments will come into force in August 2022. This is to enable people time to upgrade their storage to the new requirement.

Clearly this is a requirement for A/B licence holders only, however as holders of collectors licences are required to have storage conditions that far exceed that which applies to A/B Licence holders, L&RD advise that where the storage of long arms held on an A/B Licence exceeds that of the minimum requirement then that is sufficient under the regulations.

L&RD further advise that if approached they are happy to accommodate requests for inspection of licence holders storage facilities to advise if these adhere to the requirements of the regulations.

Finally there was a rumour circulating that L&RD had banned the storage of a firearms owner's other valuables such as jewellery, important papers etc. in the same storage facility as that of their licensed firearms. The *Firearms Act 1996* does not regulate if documents or other items can be stored in the firearms safe. However it is important to note that if documents, etc. are stored in a firearms safe then they can only be accessed by the licensed firearm holder with the exclusion of all others

## New Books



## ***The Calisher & Terry in British and Colonial Military Service 1856 -1900***

The book is a comprehensive study of the Calisher & Terry rifle, illustrated with over 170 rifle images and 50 period photographs, most of which have never been published in book form before.
