The Bondi Shooting and Changes to Firearms Laws

Following the terrorist attack in Bondi on the 14th of December the Federal and NSW governments reacted by quickly announced a tightening of firearms laws. The Federal Government convened a meeting of state leaders to begin a process in which all states would review their existing legislation.

Primarily the intentions were a review of the numbers of firearms held by individuals on A/B licences. It was also intended it would result in a buyback funded 50/50 by the Federal and State Governments to reduce these numbers. Pre-empting a review the NSW Government quickly passed legislation reducing the number of firearms that could be held on an A/B licence to four.

The concentration on A/B licenced firearms came as a result of the shooters having legally gained access to modern straight pull type bolt action longarms which are popular because they allow more rapid fire than conventional bolt action longarms. Unfortunately by that time they were already radicalized supporters of ISIS, a fact that was known to ASIO who, it appears, failed to alert the NSW police who allowed the shooter to be issued with the A/B licence. That is the rather unbelievable background to the event that has caused another official review of our national firearms laws which are already adequate.

Both the Federal and NSW Bills concentrated on firearms held on A/B licences. **Their provisions excluded firearms held on collectors licenses and H licenses.**

But as firearms legislation is the responsibility of the individual states, and as the Victorian government is conducting a review of ours, the situation in Victoria is still uncertain at present. The Victorian review is not due to be completed until early February and then will be presented to the parliament if there is a need for legislative amendments to the Firearms Act.

Accordingly at this stage the Guild cannot offer firm advice to our members. Needless to say if collectors are impacted we will fight this.

It is necessary however to express our dismay at the reaction to this tragedy by the Federal Government and also that of the NSW Government. We deplore that law abiding A/B licence holders may be forced to surrender to a buyback any firearms they possess above a potential legislated legal limit of four. Law abiding A/B licence holders were not responsible for this.

The people who committed the terrorist act at Bondi were already known to ASIO – this has been admitted. Not just known but known to have been in regular contact with ISIS. Surely once their involvement was known why wasn't the licence holder deemed a prohibited person immediately, and his firearms seized? Surely under these circumstances isn't ASIO as much to blame? Yet the people who will bear the brunt of the punishment will be hitherto law abiding gun owners.

The Guild will continue to monitor the situation as it unfolds and take all necessary action to ameliorate any harmful impact on licensed collectors
